

FIJI INFRASTRUCTURE BONDS



The Reserve Bank of Fiji, on behalf of the Government of the Republic of Fiji, invites tenders for the issue of Fiji Infrastructure Bonds up to a limit of **\$10,000,000** as follows:

Date of Bond: 28 November 2018

<u>Term</u>	<u>Fixed Coupon Rate</u>
3 years due date on 28/11/2021	3.80% p.a
Minimum (Non-Competitive Tender) :	\$1,000 (face value); thereafter multiples of \$1,000 (face value). Maximum tender is \$100,000 per maturity.
Minimum (Competitive Tender) :	\$10,000 (face value); thereafter multiples of \$1,000 (face value) per maturity.

Tenders are to be lodged in the Tender Box at Tower 2, Reserve Bank of Fiji Building, Suva between the hours of **9.00am to 3.00pm on 26 November 2018 and from 9.00am to 12.00pm on 27 November 2018**. Allotments will be notified on 27 November 2018.

Payment by bank cheque for the full face value of the amount tendered must accompany each tender lodged. If the settlement amount for an accepted tender exceeds the face value, the successful bidder is to settle the difference by **12.00pm on Wednesday, 28 November 2018**.
