

INVITATION TO TENDER



RE-OPENING OF 20 YEAR 7.00% FIXED COUPON FIJI GOVERNMENT BENCHMARK BOND TO BE HELD ON 06 SEPTEMBER 2017.

The Reserve Bank of Fiji, on behalf of the Government of Fiji, invites tenders for the above Government Bond with details below: -

Coupon	7.00%

Yield to Maturity	7.00% (as at 16/08/2017)
Maturity	16 August 2037
Interest Dates	16 February & 16 August in each year until maturity
Day count convention	Actual/Actual

Minimum (Non-Competitive Tender) : \$1,000 (face value); thereafter multiples of \$1,000 (face value). Maximum tender is \$100,000 per maturity.

Minimum (Competitive Tender) : \$10,000 (face value); thereafter multiples of \$1,000 (face value) per maturity.

Tenders are to be lodged in the Tender Box at Tower 2, Reserve Bank of Fiji Building, Suva between the hours of **9.00am to 3.00pm on 04 September 2017 and from 9.00am to 12.00pm on 05 September 2017**. Allotments will be notified on 05 September 2017.

Payment by bank cheque for the full face value of the amount tendered must accompany each tender lodged. If the settlement amount for an accepted tender exceeds the face value, the successful bidder is to settle the difference by **12.00pm on Wednesday, 06 September 2017**.
