

INVITATION TO TENDER

The Reserve Bank of Fiji, on behalf of the Government of the republic of Fiji, invites tenders for the above Government Bond with details below: -

Tenders are to be lodged in the Tender Box at Tower 2, Reserve Bank of Fiji Building, Suva between the hours of **9.00am to 12.00pm on 26 February 2019.** Allotments will be notified on the same day.

Payment by bank cheque for the full face value of the amount tendered must accompany each tender lodged. If the settlement amount for an accepted tender exceeds the face value, the successful bidder is to settle the difference by 12.00pm on Wednesday, 27 February 2019.
