Pursuant to the Fiji Government Bond Prospectus of Cash Offer dated 13 August 2018 the Government of the Republic of Fiji invites tenders for the issue of the reopened 10 year Fiji Infrastructure Bond maturing on 08 January 2029, up to a limit of **\$40,000,000** as follows:
