RESERVE BANK OF FIJI ACT 1983

NOTICE UNDER SECTION 31

IN exercise of the powers conferred on me by section 31 of the Reserve Bank of Fiji Act 1983 and on the recommendation of the Board of Directors of the Reserve Bank of Fiji, I hereby authorise the Reserve Bank of Fiji not to take into account in assessing the total demand liabilities of the Reserve Bank of Fiji, for the purposes of section 31 of the Reserve Bank of Fiji Act 1983, the bank note specified in the Schedule below—

General form and design

The obverse design of the bank note features a hibiscus flower, the Coat of Arms of Fiji, the denominational value and the signature of the Governor of the Reserve Bank of Fiji. The obverse design of the bank note also has fluorescent features, a holographic foil strip, intaglio prints and an optically variable ink which is embossed on the hibiscus flower.

The reverse design of the bank note predominantly features a dragon, the sun, denominational value, serial numbering and the *tagaga* masthead. The reverse design of the bank note also has fluorescent features.

CHARACTERISTICS OF BANK NOTES

IN accordance with section 25(3) of the Reserve Bank of Fiji Act 1983, the Reserve Bank of Fiji gives notice that it shall commence the issue of Fiji 100 cents non-circulation numismatic bank notes with effect from 8 August 2023 using the characteristics set out in the Schedule below in addition to the bank notes and coins currently in circulation.
